Plaintiffs Michael Allagas, Arthur Ray, Brett Mohrman ("Plaintiffs") and Defendants BP Solar International, Inc. ("BP") and Home Depot U.S.A., Inc. ("HD") respectfully submit this joint stipulation.

1. Whereas, on December 22, 2016, this Court issued an order and judgment granting final approval of a class action settlement and dismissing the class action with prejudice.

2. Whereas, on July 29, 2019, the parties filed a joint case management conference statement where they stated:

- a. Since December 22, 2016, the parties have issued nationwide class notice of the settlement twice and relief has been provided to approximately 1,700 claimants.
- b. Approximately \$16 million remains in the common fund and the claims rate is decreasing each month.
- c. The parties are interested in amending the class settlement to include an additional integrated roof tile known as model number BP365TS manufactured between 2005 to 2007.

3. Whereas, on September 10, 2019, this Court issued an order that the parties file a stipulation to modify the class action settlement.

4. Whereas, on November 22, 2019, the parties filed a Joint Stipulation for Preliminary Approval of Addendum to Class Settlement Agreement.

5. Whereas, on February 3, 2020, this Court issued an order granting Preliminary Approval of Addendum to Class Settlement Agreement in which this Court ordered the parties to file a stipulation for Final Approval of Addendum to Class Settlement Agreement. Therefore, the parties agree and stipulate that BP365TS model panels manufactured between 2005 to 2007 should be included as a Class Panel and agree to amend the class settlement through an addendum that was attached to the Joint Stipulation for Preliminary Approval of Addendum to Class Settlement Agreement.
